### WHO IS OBLIGED TO ATTEND THE ADAPTATION AND INTEGRATION COURSE?

Most non-EU foreigners who have been issued a **long-term residence** permit or **permanent residence** permit after 1 January 2021 are required to complete the adaptation-integration course.

The course must be completed within 1 year of receiving the residence permit.

### AMENDMENT TO THE ACT ON THE RESIDENCE OF FOREIGNERS

Effective from 2 August 2021, the conditions for applying for a registration certificate for EU citizens have changed. The submission of this application is now subject to an administrative fee of CZK 200. This fee also applies to applications for amendments to the residence document of an EU citizen or their family member.

There has also been a change in the obligation to provide comprehensive health insurance for foreigners entering our territory for more than 90 days and insurance for new-born children.
